Goods' Movement Inventory Analysis Proposal

Overview

The OTC Mobile Source committee has been charged with developing a goods' movement strategy for the OTR. The charge was to develop a strategy that will focus on all aspects of goods' movement throughout the OTR, whether by rail, water, air, or road. In order to develop an efficient strategy, the emissions produced in the different mobile sources involved in goods' movement must be evaluated.

Emissions Inventory

MARAMA, in conjunction with the OTC Modeling committee and the states in the OTR, has been developing a SIP quality emissions inventory for 2007, as well as a projected 2020 inventory. The 2007 inventory, for all sectors, is expected to be completed by the end of March 2011 and the 2020 inventory is expected to be completed by the end of June 2011 for all mobile sectors (the nonroad inventory is already complete for both 2007 and 2020). The OTC Mobile Source committee will utilize the 2007 & 2020 projected inventory. In the case where the onroad mobile portion of the 2020 projected inventory has not been completed quickly enough to complete the analysis an adjustment factor would be applied to the 2007 emissions based on EPA's national inventory analysis.

Proposed Process

- 1. Develop a comprehensive list of source classification codes (SCCs) to include in the analysis.
- 2. Determine emissions levels for the sources in each SCC based on the 2007 and 2020 inventories, with a focus on emissions during the month of July.
- 3. Produce a technical evaluation of which source types are the most important to control as part of a comprehensive goods' movement strategy.




Figure 1: Goods' Movement
