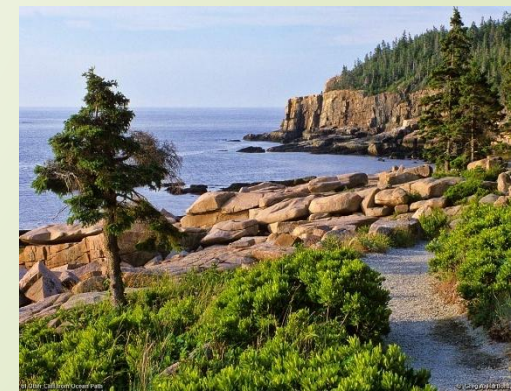

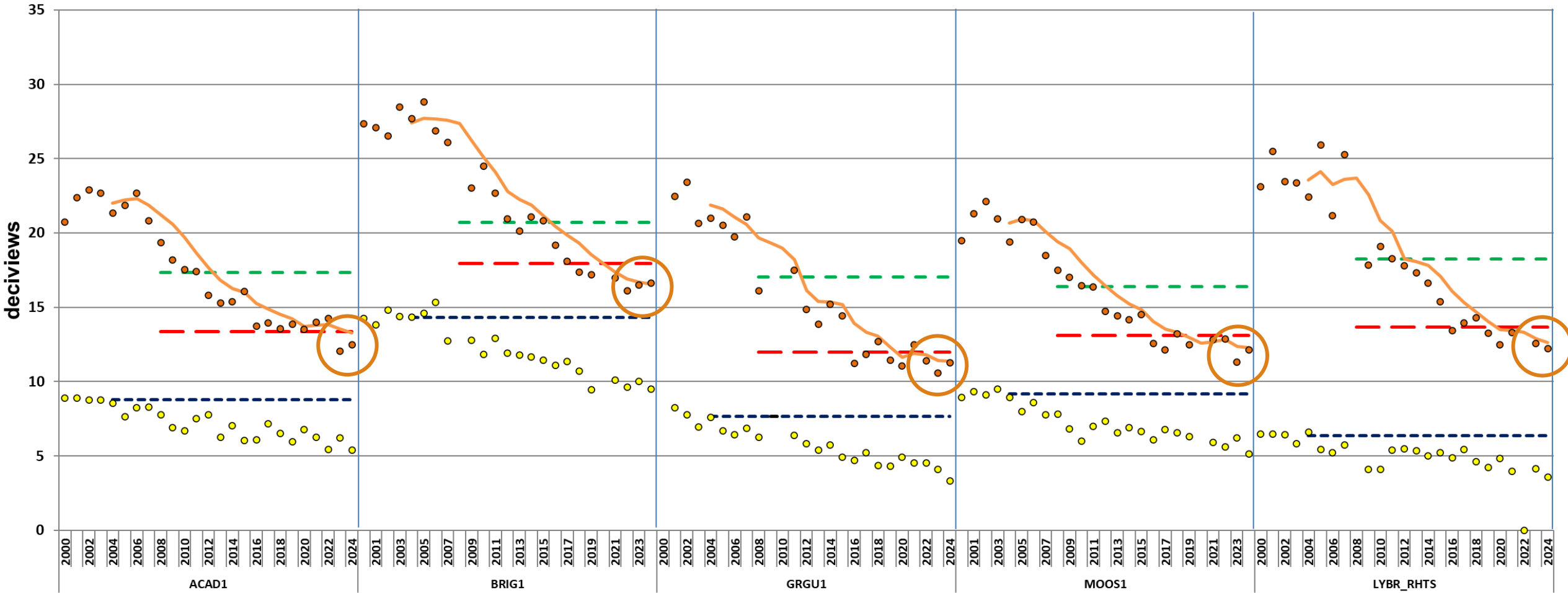

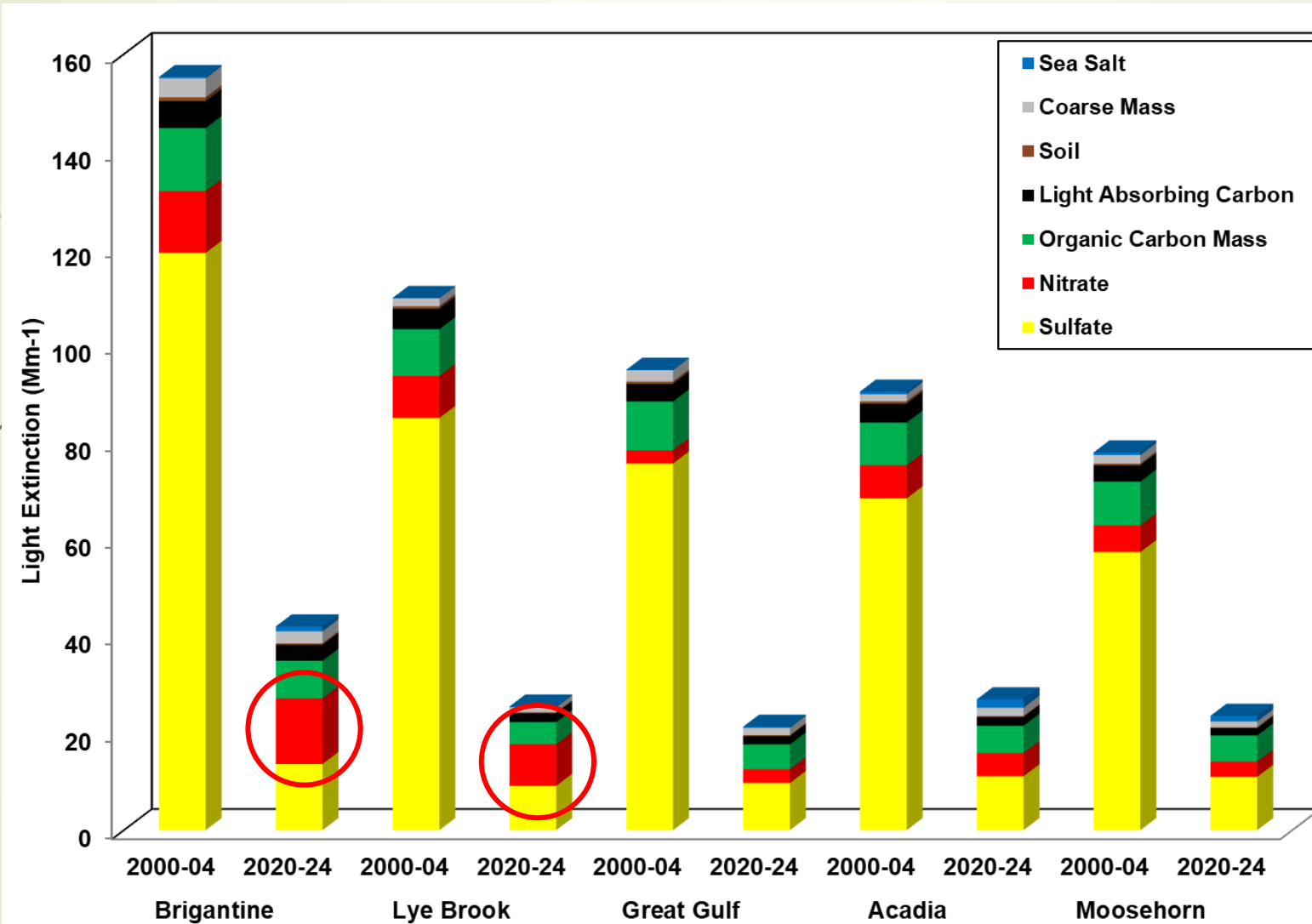
# 2024 Visibility Metrics

## Recent TSC Activities, Comments on SIP Actions

Our comments on RH SIPs – HI, IL, OK, RI, AK, NV, TN:

- Oppose EPA's new URP policy for demonstrating reasonable progress
- Oppose EPA's Feb 20, 2026 guidance update dictating that grid reliability be taken into account when evaluating the statutory energy factor

## Recent TSC Activities, Comments on the RHR ANPRM

Our comments on the RHR ANPRM:

- Oppose the URP policy and reaffirm the use of RPGs
- Support the continued use of the 20% MID and 20% Clearest Days metrics
- Reaffirm the use of natural conditions as the RHR end goal
- Generally oppose any sort of “safe harbor” approach, but suggest that some SIP requirements could be suspended if monitored haze indexes below RPGs

## Recent TSC Activities, Comments on the RHR ANPRM

Our comments on the RHR ANPRM (cont'd):

- Reaffirm the importance of IMPROVE
- Support the continued use of the 10-year planning period
- Support the continued requirement of a 5-year PR, but suggest that some SIP and PR requirements are redundant and could be streamlined
- Reaffirm the importance of the RPOs
- Express concern with recent SIP actions and how they might frame potential RHR changes

## Future TSC Focus Areas

- When they become available, review proposed RHR updates and provide comment
- Update training materials and SIP/PR templates to accommodate RHR changes
- Work with other OTC committees, other RPOs, and EPA, as appropriate, to push for robust future-year inventories and modeling
- Promote consistency in modeling and other techniques for determining contribution to Class I areas
