Position Description

The Ozone Transport Commission, an organization of 13 Mid-Atlantic and Northeast State (including the District of Columbia) Environmental Commissioners and Air Directors, is seeking an Executive Director to serve in its Washington, D.C. Office.

The Executive Director position of the Ozone Transport Commission provides leadership and management for the organization, advising and leading the Commission in planning, policy and organizational matters. The Executive Director directly manages the business and administrative functions of the organization, including grants management, personnel policy and benefits, and day-to-day operations of the organization. In addition to these responsibilities the Director identifies and leads the Commission in development of air pollution programs and policy for the region, including management of specific programs and projects related to air pollution in the region. The Executive Director also has development responsibilities for the organization, ensuring a stable and predictable source of funding for the organization as necessary for it to accomplish its mission.

The Executive Director provides leadership and manages the organization of 6 staff and current budget of approximately \$1.5 million per year regarding development and implementation of air pollution programs and policy for the region.
